

- helps promote the image of TWGHs and builds community relations
- donates and actively participates in fund-raising activities of TWGHs
- ensures a balanced, accurate and timely assessment of TWGHs financial position
- reports appropriately to external stakeholders including the Advisory Board


## 委員會及其職權範圍 Committees and their Terms of Reference

TWGHs is managed on a committee-rule basis, with the Board of Directors as the governing body. The Board is assisted by an Executive Committee in governing the Group. Under the Board, various committees, each overseeing a particular function or aspect of service provided by the Group, advise and recommend to the Board on the formulation of policies while giving directives to staff for implementation. They include the Medical and Health Committee, Education Committee, Community Services Committee, Property Committee, Fund-raising and Corporate Communications Committee, Human Resources Committee, Staff Retirement Schemes Management Committee, Finance Committee, Information Technology Committee, Audit Committee and Records and Heritage Committee. The Board also participates actively in the management and development of TWGHs' 5 hospitals through the Hospital Governing Committees of the individual hospitals. Tung Wah College is governed by the Board of Governors, of which the chairperson is appointed by the TWGHs Board of Directors.

The various Board-level Committees are formed with corresponding executivelevel Policy Working Groups, as required, to strengthen internal controls and enhance corporate governance through the separation of the Group's governance and management.

為增強東華三院內部管理運作及企業管治, 委員會亦按需要相應成立管理層政策工作小 組,分開機構的管治和管理。

A Joint Meeting between the TWGHs Advisory Board and the Board of Directors 2015/2016 was held on 13 November 2015 to strengthen communication with the Advisory Board and to solicit their advice and support for the Group's work and major development plans. This resulted in the exchange of valuable opinions for the enhancement of the governance and management of the Group and its vast service network. A luncheon gathering was held prior to the meeting to help build closer relationships.

#### Compilation of quarterly situation reports

Situation reports on TWGHs policy issues, significant matters and undertakings, as well as major activities held, were compiled and submitted to the Advisory Board on a quarterly basis to strengthen communication between the Advisory Board and the Board of Directors, and to enhance the transparency of the Group's operations.

# 組織、職能及宗旨 Organization, Functions and Objectives

在行政架構上,東華三院共設有七科及四 處,分別為醫務科、教育科、社會服務科、 物業科、籌募科、政務科、財務及採購科、 人力資源處、資訊科技處、企業傳訊處及稽 核處。執行總監掌管東華三院的行政運作, 並由各部門主管協助處理日常事務。

The administrative structure of TWGHs comprises 7 Divisions and 4 Branches, namely Medical Division, Education Division, Community Services Division, Property Division, Fund-raising Division, Administration Division, Finance & Supplies Division, Human Resources Branch, Information Technology Branch, Corporate Communications Branch and Audit Branch. The Chief Executive is the head of administration and is assisted by the heads of various Divisions and Branches in the management of TWGHs services and administrative affairs.

## 行政總部的工作。 Work of Administration Headquarters

東華三院轄下共有五間醫院,設有病床二千 六百五十張。五間醫院分別為港島區的東華 醫院、東華東院及東華三院馮堯敬醫院,以 及九龍區的廣華醫院和東華三院黃大仙醫 院。醫務科負責統籌及協調東華三院董事局 及醫院管理局之間有關管理及發展五間醫院 的一切事宜,並於需要時作出支援,以確保 五間醫院能有效及獨立運作。

該科並負責策劃、發展及管理東華三院的中 西醫療衞生服務共二十九個單位,包括分別 位於廣華醫院(與香港中文大學合作)、東 華醫院(與香港大學合作)、東華三院黃大 仙醫院(與香港浸會大學合作)、東華東院 (與香港理工大學合作)、東區尤德夫人那 打素醫院(與香港大學合作)及位於何文田 愛民邨(與香港浸會大學合作)(服務至二 ○-五年十一月底)的中醫藥科研中心、中 西醫藥結合治療中心/服務、中西醫結合健 康管理中心(上醫館)、中醫流動診所、中 醫外展服務、中藥檢驗中心、中央煎藥中 心、中醫普通科門診部、婦女健康普查部、 綜合診斷及醫療中心、電腦掃描中心、血液 透析中心、牙科診所、長者牙科外展服務及 長者家居復康外展服務。

#### **Medical Division**

There are 5 hospitals in the Group with a total of 2,650 beds. They are Tung Wah Hospital, Tung Wah Eastern Hospital and TWGHs Fung Yiu King Hospital on Hong Kong Island, and Kwong Wah Hospital and TWGHs Wong Tai Sin Hospital in Kowloon. The Division is responsible for coordinating all matters relating to the 5 hospitals between the TWGHs Board of Directors and the Hospital Authority, and providing support when required to ensure that each hospital operates efficiently and independently.

The Division also plans, develops and administers 29 TWGHs medical and health services units. These include the Chinese medicine clinical centres at Kwong Wah Hospital (in collaboration with The Chinese University of Hong Kong), Tung Wah Hospital (in collaboration with The University of Hong Kong), TWGHs Wong Tai Sin Hospital (in collaboration with Hong Kong Baptist University), Tung Wah Eastern Hospital (in collaboration with The Hong Kong Polytechnic University), Pamela Youde Nethersole Eastern Hospital (in collaboration with The University of Hong Kong) and Oi Man Estate, Homantin (in collaboration with Hong Kong Baptist University)(service ended at the end of November 2015). It also comprises the integrated Chinese and Western medicine treatment centres/services, a centre of integrated health management, Chinese medicine mobile clinics, Chinese medicine outreaching services, a Chinese medicine control centre, a centralized decoction centre, Chinese medicine general outpatient clinics, well women clinics, an integrated diagnostic and medical centre, a computed tomography imaging centre, a haemodialysis centre, dental clinics, outreaching dental services, and outreaching home care services for the elderly.

#### 教育科

東華三院現時辦有中學十八所、小學十三 所、幼稚園十五所,為智障學童而設的特殊 學校共兩所、一所教育心理服務中心、一所 才藝教育中心、一所音樂學院以及一所為幼 兒而設的遊戲學習中心。為配合政府擴展專 上教育的發展方向,本院於二〇〇五年創辦 以副學士學位課程為主的香港中文大學 - 東 華三院社區書院,並於二○一一年過渡為開 辦學士學位課程的東華學院。

教育科肩負策劃及發展東華三院教育服務的 責任,同時為所有院屬學校的法團校董會提 供專業及行政管理支援服務。教育科與屬校 緊密聯繫,共同協作,以期促進學校的專業 水平和教育質素。為了向學校提供專業輔導 及諮詢服務,協助解決學生不同的學習需 要,教育科設有東華三院何玉清教育心理服 務中心,除了直接服務有需要的學生外,還 為學校教師及家長提供訓練課程及活動。

#### 社會服務科

社會服務科負責策劃、發展及管理東華三院 屬下二百零九個社會福利及公共服務單位, 其中包括五十九個安老服務單位、六十九個 青少年及家庭服務單位、四十四個復康服務 單位、十九個社會企業單位及十八個公共服 務單位。

該科負責的服務多元化,涵蓋提供護理安老 程度至療養程度服務的各類安老院舍、長者 地區及鄰舍中心、日間護理中心、長者家居 照顧及支援服務、認知障礙症專門服務、兒 童之家、女童宿舍、寄養服務、幼兒園、早 期教育及訓練中心、就業援助服務、青少年 及家庭綜合服務、學校社會工作服務及學生 輔導服務、專門輔導服務、食物援助服務、 熱線服務、智障人士日間活動中心暨宿舍、 綜合職業復康中心、社區支援服務、社區精 神健康復康服務、嚴重殘疾人士及視障人士 護理院、長期護理院、專門招聘弱勢社群的 社會企業、全人健康中心、殯儀館、義莊、 義山及靈灰安置場、廟宇、簽檔和牌位庫 等。

#### 物業科

物業科負責策劃東華三院的物業發展、管理 轄下的物業和出租事宜。該科積極開拓發展 機會,藉此滿足服務需求及確保穩定和金收 益,以支持東華三院行政和發展計劃的費 用。此外,物業科並為其他科/處提供專業 意見,監督各項工程,以確保所有工程質素 良好,合符預算支出及依時完工。

該科同時致力推行及監察東華三院的環保工 程,使東華三院邁向日趨完善的綠色機構。

#### **Education Division**

TWGHs is currently operating 18 secondary schools, 13 primary schools, 15 kindergartens, 2 special schools that cater for students with intellectual disability, an educational psychology service centre, a talent education centre, an academy of music, and a playgroup centre for pre-school children. In response to government's call for the expansion of tertiary education, The Chinese University of Hong Kong - Tung Wah Group of Hospitals Community College was founded in 2005, offering sub-degree programmes. It has been converted to Tung Wah College, a degree-awarding institute established in 2011 that offers degree programmes.

The Education Division is responsible for the planning and development of TWGHs education services. It provides professional and management support for all Incorporated Management Committees of TWGHs schools, and coordinates with affiliated schools for professional enhancement and the promotion of quality education. To provide schools with professional guidance and consultation support, and to assist schools in catering for students' diverse learning needs, the Division set up the TWGHs Ho Yuk Ching Educational Psychology Service Centre, offering direct service for students and training programmes for teachers and parents.

#### **Community Services Division**

The Community Services Division plans, develops and administers 209 social welfare and traditional service centres, including 59 elderly service centres, 69 youth and family service centres, 44 rehabilitation service centres, 19 social enterprises and 18 traditional service centres.

The wide spectrum of services covers various residential care homes for the elderly, ranging from the care and attention level to infirmary care level, district community centres, neighbourhood centres and day care centres for the elderly, home care services for the elderly, dementia care services, small group homes, girls' hostel, foster care service, nursery schools, an early education and training centre, employment assistance services, integrated services for families and young people, school social work services and student guidance services, specialized counselling services, food assistance services, hotline services, day activities centres cum hostels for the mentally handicapped persons, integrated vocational rehabilitation service centres, community support services, community mental health services, care and attention homes for the severely disabled persons and the aged blind, long-stay care home, social enterprises operated by disadvantaged groups, a holistic healthcare centre, funeral parlours, a coffin home, cemeteries and columbarium, temples, fortune-telling stalls, and commemoration hall.

#### **Property Division**

The Property Division formulates development plans for TWGHs properties, and oversees the management and leasing of rental properties. It also makes a great effort to redevelop TWGHs properties and explore development opportunities to meet service needs and optimize the Group's rental income to finance its operation and development projects. In addition, the Division offers professional advice to other Divisions/Branches, and supervises all projects to ensure they are completed on time, within budget and to a high standard.

The Division also takes charge of the implementation and supervision of the Group's green initiatives to make TWGHs an ever-improving green organization.

#### 籌募科

籌募科負責策劃和籌辦各項籌款活動,處理 計劃性和其他特別捐助,包括單位命名、遺 產、股票及物業捐贈等。籌募科亦會拓展有 效的捐款途徑及處理與籌款有關的後援工 作,如簽發捐款收據及保存所有善款記錄 等。此外,籌募科亦會執行與籌款有關的公 關工作,包括維繫和拓展善長網絡,並向董 事局建議制訂和檢討各項有關籌款的政策和 策略。

#### 政務科

政務科負責監察及策劃有關籌組董事局的事 務,為董事局提供行政及文書支援服務,處 理東華三院有關的條例,執行東華三院歷屆 總理聯誼會的行政工作及管理東華三院李兆 忠紀念大樓禮堂,並為行政總部管理層擔任 文書工作。此外,政務科負責推廣和建立董 事局的公眾形象,透過籌辦董事局的社交和 拜訪活動,加強本院與政府部門及有關機構 和團體的溝通和聯繫。該科又協助各部門安 排慶典及活動,並透過轄下總務組為行政總 部提供收發文件、運輸及庶務等中央服務。

#### 財務及採購科

財務及採購科以伙伴合作模式,支援各科/ 處及其屬下服務單位以提供優質服務,並透 過實施適當的內部監管,確保東華三院的資 源及資產得以有效地運用。該科除根據法例 及東華三院的規定,為各科/處及其屬下服 務單位(醫院除外)提供中央會計、財務管 理及採購物資服務外,同時負責管理東華三 院的資金及確保各項計劃和活動獲得適當的 財政安排。該科亦協助搜集市場產品及物價 資料,冀為東華三院採購合適的物資和服 務。

#### **Fund-raising Division**

The Fund-raising Division is responsible for planning and organizing fundraising activities, and handling planned giving and other specific donations, including naming of service centres, donation of bequests, shares and properties etc. Exploring new effective donation channels, and providing fundraising back-office support, such as issuing donation receipts and maintaining donation records, are also within the job scope of the Division. In addition, it looks after related public relations work, including maintaining and expanding the donor network, and provides recommendations to the Board of Directors regarding the adoption and review of fund-raising policies and strategies.

#### **Administration Division**

The Administration Division is responsible for facilitating and monitoring the formation of the Board of Directors, and for providing administrative and secretarial support services for the Board. It takes charge of the work in connection with the relevant Ordinances of TWGHs, the administrative work of the Association of Past and Present Directors of the Tung Wah Group of Hospitals, and the management of the Assembly Hall of TWGHs Li Shiu Chung Memorial Building. It also provides secretarial support for senior management of Administration Headquarters. The Division builds and promotes the public image of the Board of Directors by organizing social functions and courtesy visits for the Board. These activities are also geared towards strengthening communication and relationship building with government departments, associated organizations and the community at large. The Division also helps arrange the protocol for ceremonial events and functions initiated by other Divisions and Branches, and provides central services, including receiving and dispatching, transportation and menial support for Administration Headquarters.

#### Finance and Supplies Division

The Finance and Supplies Division partners with and supports all other Divisions/Branches and service centres in the delivery of quality services. It ensures that appropriate internal controls are in place to facilitate the efficient and effective utilization of resources and to safeguard TWGHs assets. It provides central accounting, financial and purchasing functions for all Divisions/Branches and service centres (except hospitals), in compliance with both statutory and Group requirements. The Division manages the Group's funds and ensures that projects and activities are properly financed. It also helps collect market information on products and prices in order to secure appropriate procurement of goods and services for the Group.

#### 人力資源處

人力資源處為東華三院超過八千四百名非醫 院員工,提供人力資源策劃、發展及管理服 務,致力加強人才管理系統,使有關實務常 規與時並進,配合各種環境轉變的需要及政 府所修訂或頒布與僱傭相關的法例。該處主 要工作範疇包括規劃人力編配及招募、薪酬 及假期福利、員工訓練及發展、職業安全及 健康、工作表現評核及員工紀律,以及員工 離任及退休等。為照顧超過一萬四千名醫院 及非醫院員工的需要,該處亦積極推廣關懷 員工文化,制訂和檢討員工福利計劃,又舉 辦生活與工作平衡活動,以及維持有效的溝 通和諮詢途徑。

為推動長遠且卓越的可持續發展,該處致力 為各科/處/服務單位/學校提供高效率及 效能的專業支援服務,並建立及維持一支盡 心盡力、團結一致,且具備專業才能和應變 能力的工作團隊,以達成東華三院的企業使 命。

#### 資訊科技處

資訊科技處負責制訂資訊科技策略、設計和 推行有關方案,並提供資訊系統支援及辦公 室自動化服務,以提升本院的運作效率。目 前,本院配置各類型的資訊應用系統及基礎 設施,以支援醫療衞生及社會服務單位的前 線工作,並協助機構處理行政及管理工作。 資訊科技處服務廣泛,工作範疇包括項目策 劃和管理、系統研究、設計和分析、程式編 寫及測試、試行及隨後運作支援、設施管 理、電腦設施的評估及測試,以及為使用者 提供技術支援等服務。資訊科技處除積極推 動本院在不同範疇的運作上普及應用資訊科 技外,亦致力加強機構在資訊科技方面的管 治,透過系統化的機制,提升本院的資訊保 安和信息管理;又採納資訊科技的實務準 則,以確保電腦普及化政策能有效執行。

#### **Human Resources Branch**

With over 8,400 non-hospital staff in the TWGHs workforce, the Human Resources Branch is committed to planning, developing and managing the valuable human resources and enhancing the talent management system, in order to align the relevant practices with changing needs and employmentrelated ordinances as they are amended or newly introduced by the Government. The main work involves manpower planning and acquisition, remuneration and leave benefits, staff training and development, occupational safety and health, performance management and staff discipline, and cessation of service and retirement. The Branch plays a proactive role in promoting a staff-oriented caring culture, improving staff welfare benefits and schemes, launching work-life balance activities and maintaining effective staff communication channels for more than 14,000 hospital and non-hospital staff.

In pursuit of sustainability for future development and excellence in best practices, the Branch aims at providing efficient and effective professional support services for all Divisions/Branches/service centres/schools, and building a dedicated and cohesive workforce with the professional competency and versatility to achieve the TWGHs corporate mission.

#### Information Technology Branch

The Information Technology Branch is responsible for the formulation of IT strategies, related solution planning and implementation as well as provision of support services for the Group in order to achieve operational efficiency. There are currently various IT application systems and infrastructure systems to support front-line operations in medical and health and community services, as well as corporate management and administration functions. The Branch provides a full spectrum of IT services, including project planning and management, system study, design and analysis, programming and testing, commissioning and subsequent operating support, facilities management, computing facilities evaluation and equipment testing, and end-user computing support. In addition to promoting diffusion of IT to facilitate its application in various operations of the Group, the Branch helps strengthen IT governance geared to enhancing the IT security and information management of the Group, using a systematic approach. The Branch has adopted best practices in information technology to ensure that the computerization policy can be implemented effectively.

#### 企業傳訊處

企業傳訊處的職責涵蓋東華三院對內、對外 的資訊傳遞工作及策略,並透過不同的媒介 及品牌推廣活動,與本院各個持份者保持緊 密聯繫,以提升本院的正面形象和透明度。 該處致力與傳媒建立良好關係,期望透過傳 媒幫助,讓公眾掌握本院多元化且不斷革新 的服務和最新發展動向。

此外,企業傳訊處亦協助機構處理危機應 變,透過適時的回應及行動,把突發事故所 帶來的負面影響減至最低。該處同時負責出 版刊物、管理網頁內容及與外界合作籌劃活 動,營造和鞏固本院最具規模和與時並進的 慈善機構形象,以爭取公眾人士對本院的支 持。

該處亦處理外界包括傳媒的查詢、有關拍 攝、義工服務和探訪的申請,並按照一套完 備的程序處理公眾投訴及建議。

#### 稽核處

稽核處為東華三院各項服務運作及活動進行 獨立和客觀的審核,並透過稽核委員會直接 向董事局報告。審核的目的是要評估院內內 部監控機制的有效性,包括業務運作、財 務、合規與風險管理各方面,從而加強東華 三院的機構管治,提高運作效率及資源運用 的效能。此外,本處每年進行整體風險評 估,制訂管理檢查表報告及平衡計分卡,以 評估各部門於風險管理、年度工作計劃各方 面的達標效能。

#### **Corporate Communications Branch**

The Corporate Communications Branch is responsible for both the internal and external communication initiatives and strategies of the Group. The Branch is dedicated to enhancing the Group's positive image and transparency by building links with different stakeholders via various channels and branding activities. Sustaining a strong relationship with the media, the Branch seeks to provide the public with adequate information on the Group's diversified and continually updated services, as well as new developments through engagement and collaboration with various media.

The Branch also supports and advises the Group on crisis management. It takes timely action in responding to incidents to minimize any possible adverse effects. The Branch strives to enhance the status and popularity of TWGHs - the most well-established charitable organization in Hong Kong, evolving in pace with Hong Kong society - for greater public recognition and support by producing corporate publications, managing the contents of TWGHs website and collaborating with external parties.

All external enquiries and requests, including those from the media, for shooting, performing voluntary services, and visits, are processed by the Branch. Complaints and recommendations from the public and service users are handled in accordance with a set of well-established procedures.

#### **Audit Branch**

The Audit Branch performs independent and objective reviews of various service operations and activities in TWGHs, and reports directly to the Board through the Audit Committee. The objectives of the reviews are to assess the effectiveness of internal controls, in terms of operational, financial, compliance and risk management, in order to enhance the overall corporate governance of TWGHs, as well as the efficiency and effectiveness of the Group's operations and use of resources. The Branch also performs comprehensive risk assessment for TWGHs, and conducts management checklists and balanced scorecard assessments for the Group, in order to assess the effectiveness of risk management and of steps to achieve the annual plan.

The day-to-day administration and functions of the Audit Branch is supervised by the Chief Executive.
